

## **FAQs FOR RESUMPTION OF SPORT AND PHYSICAL EXERCISE & ACTIVITY FOR PHASE THREE (“SAFE NATION”) – SPORT EVENT PILOTS**

### **A. ON SPORT EVENT PILOTS APPLICATION**

**Qn: What sport events are currently permitted?**

Ans: Sport events that involve 50 people or less (including participants, spectators, officials, event crew and support staff) and meet the required safe management measures indicated in the [Advisory On Safe Advisory For Resumption Of Sport And Physical Exercise & Activity For Phase Three \(“Safe Nation”\) updated on 29 January 2021](#), can proceed.

For all sport events involving more than 50 persons (including participants, spectators, officials, event crew and support staff), organisers will have to submit an application using the form [here](#) and email it to **SPORT\_Covid@sport.gov.sg** for endorsement minimally 30 days prior to the event, and are advised not to carry out related marketing/publicity efforts before receiving endorsement from Sport Singapore. **Qn: I am interested to organise a sport event. How do I apply for the sport event pilot?**

Ans: For all sport events involving more than 50 persons (including participants, spectators, officials, event crew and support staff), organisers will have to submit an application using the form [here](#) and email it to **SPORT\_Covid@sport.gov.sg** for endorsement minimally 30 days prior to the event, and are advised not to carry out related marketing/publicity efforts before receiving endorsement from Sport Singapore. **Qn: I have submitted my application. What is the process like and when can I expect a decision?**

Ans: Upon submission of application (please ensure that application is submitted at least 30 days prior to the event), Sport Singapore will process the application and will be in touch with the organiser for any clarifications if required. Otherwise, a written response will be provided within 14 business days. Organisers are advised not to carry out related marketing/publicity efforts before receiving endorsement from Sport Singapore.

**Qn: Is there a whitelist of venues that I can hold my sport event at, or can my event be held at any venue of my choice?**

Ans: All suitable venues can be used for sport events. Organisers will need to assess the suitability of the venue in terms of deployment of the required safe management measures (SMM). **Qn: I want to include live performances as part of my sport event. Do I need to seek separate approval from MTI on this?**

Ans: For sport events, live performance elements will be subject to approval. Event organisers may submit their proposals to Sport Singapore for assessment.

**Qn: Can my sport competition/tournament have spectators?**

Ans: Sport tournaments and competitions with spectators will be treated as Live Spectator Sport Events (under para 4a of Addendum To Advisory On Safe Resumption Of Sport And Physical Exercise & Activity For Phase Three (“Safe Nation”) – Information On Organising Sport Event Pilots dated 6 April 2021).

**Qn: Can my mass participation sport events have spectators?**

Ans: At this juncture, mass participation sport events will not be allowed to have invited spectators. Organisers are to put in place measures to prevent the spontaneous gathering of onlookers for such events.

**B. ON PRE-EVENT TESTING (PET)**

**Qn: When will PET need to be done?**

Ans: PET needs to be implemented for live spectator sport events involving more than 250 spectators up to a maximum of 750 (in zones of up to 50 persons), or the safe capacity for the venue, whichever is lower.

**Qn: How will PET for sport events be done? Will these tests be carried out on-site or at clinics?**

Ans: PET needs to be implemented for live spectator sport events involving more than 250 spectators up to a maximum of 750 (in zones of up to 50 persons), or the safe capacity for the venue, whichever is lower. Event organiser shall decide on the method for pre-event testing and communicate this to the attendees prior to event.

**Qn: Who will bear the cost of PET?**

Ans: Event organiser or individual participating/attending the sport events shall bear the cost of the PET.

**Qn: For PET, what is the validity of the results?**

Ans: The validity of COVID-19 test result is 24 hours from the time an individual was registered in-person at the testing premise. As long as the result is still valid, the person may enter and stay in the premise of the event.

**Qn: Do participants who have been vaccinated need to undergo PET?**

**Ans:** Local residents who have completed the full COVID-19 vaccination regimen (with a further two weeks from the second dose to develop sufficient protection) are exempted from pre-event testing. They will have to produce a valid vaccination certificate to gain entry into the sport events.
